# HISTORIC PRESERVATION ADVISORY BOARD JANUARY 5, 2017

The Historic Preservation Advisory Board of the City of McKinney, Texas met in regular session in the Council Chambers of the Municipal Building on Thursday, January 5, 2017 at 5:30 p.m.

Votes were tabulated, a run-off was held, and the top 14 houses were announced.

Mr. Giersch asked for feedback on the current calendar. The Board and Staff discussed possible changes and the various tasks associated with producing the annual calendar. Some of the Board Members volunteered to work on certain calendar tasks.
