Mayor Loughmiller called for Consideration/Discussion/Action on the Minutes of the City Council Regular Meeting of October 15, 2013.

Council member Ricchi stated that within the minutes, agenda item 13-1089 relating to the airport budget. Mr. Ricchi stated during the discussion, the numbers relating to the fuel charges did not made sense.

There are other departments whose work at the airport was not included in the budget. City Manager Jason Gray stated the City does not charge each department if they need other departmental services. Council unanimously approved the motion by Council member Harris, seconded by Council member Ricchi, to approve the minutes of the City Council Regular Meeting of October 15, 2013.

Ordinance to Extend the School Zone for Imagine Charter School. Traffic Engineer Robyn Root stated that this item is an extension of the Imagine Charter School zone due to some operational changes that the school has made that has had an impact on vehicle stacking on Jordan Road.

Ms. Root stated that they are working on extending the turn lane off of Virginia Parkway to help reduce the amount of traffic stacking on Virginia Parkway. Ms. Root stated that they are also requesting that TxDOT add some additional signage to identify the school zone and hopefully to slow down the traffic in that area. Council unanimously approved the motion by Council member Ricchi, seconded by Council member Pogue, to approve an Ordinance to Extend the School Zone for Imagine Charter School. Council approved the motion by Mayor Pro-Tem Ussery, seconded by Council member Kever, to close the public hearing. Council member Kever stated that she understands both the rights of the property owner as well as the rights of the property owners adjacent to the property. She cannot ignore the other 300 plus citizens that are opposed to the project and she cannot support the request to rezone the subject property. Mayor Loughmiller stated that Bob Tomes has been a great McKinney citizen but his responsibility as Mayor is to represent the citizens of McKinney and at this point he is opposing this item. Council approved the motion made by Council member Harris, seconded by Council member Day, to table this item to the December 3, 2013 meeting, with a vote of 4-2-1, Mayor Loughmiller and Mayor Pro-Tem Ussery voting against. Council member Pogue abstained.

Council member Pogue returned to the dais.

Mayor Loughmiller called for Consideration/Discussion/Action on all Matters Incident and Related to the Issuance and Sale of "City of McKinney, Texas, Tax and Limited Pledge Airport Revenue Certificates of Obligation, Taxable Series 2013", including the Adoption of an Ordinance Authorizing the Issuance of such Certificates of Obligation. City Manager Jason Gray stated that this is an item that they have been briefed on in the past regarding a previous authorization for the issuance of certificate obligations for the airport acquisition. This item is being

brought back due to an error in publication that has been rectified. Council approved the motion made by Council member Day, seconded by Mayor Pro-Tem Ussery, to approve the issuance and sale of "City of McKinney, Texas, Tax and Limited Pledge Airport Revenue Certificates of Obligation, Taxable Series 2013", including the adoption of an Ordinance authorizing the issuance of such Certificates of Obligation with a vote of 4-2-1, Council member Pogue and Ricchi voting against. Mayor Loughmiller called for a Public Hearing to Consider and Discuss on the Request by Wynne Jackson, Inc., on Behalf of Coit and Plano Parkway, Ltd., William and Barbara Docekal, Ronald Alan Gibson, Erwin H. Gibson, Sr., Armon D. and Mary Ann Gibson, and Wesley J. and Evelyn E. Valek, a Petition to Annex Fewer than 127 Acres, Located on the North and South Sides of Wilmeth Road and on the East and West Sides of County Road 161 (Future Ridge Road) Together with the Adjacent and/or Abutting Segments of Wilmeth Road and Ridge Road as Required by State Law. Director of Planning Michael Quint stated that the property owners are requesting to annex 127 acres into the City of McKinney. When considering annexing a property, the City considers a number of factors which include current population of the land to be

annexed, the ability for the city to provide city services and utilities and the fiscal impact to the City. He stated that staff has evaluated these factors and have no concerns. State law requires three public hearings to take place prior to annexing property. The first public hearing was held on November 4<sup>th</sup> at 5:30 p.m., this is the second public hearing, and the third and final public hearing will be held on December 3, 2013 along with the development agreement as well as the rezoning request. Mr. Quint stated that the rezoning signs are being posted tonight as are required to be posted on the Tuesday before the Planning and Zoning meeting that will be held on November 12, 2013. Mayor Loughmiller called for public comment and there was none. Council unanimously approved the motion by Council member Pogue, seconded by Council member Day, to close the public hearing.

Mayor Loughmiller called for a Public Hearing to Consider/Discuss/Act on the Request by Abernathy, Roeder, Boyd and Joplin, on Behalf of VCIM Partners, L.P., for Approval of a Request to Rezone Fewer than 4 Acres from "PD" - Planned Development District and "REC" - Regional Employment Center Overlay District to "PD" - Planned Development District and "REC" - Regional Employment Center Overlay District, Generally to Modify the Development Standards, Located on the Southwest Corner of Van Tuyl Parkway and TPC Drive, and Accompanying Ordinance. Director of Planning Michael Quint stated that the applicant is requesting to rezone the subject property generally to allow for a wedding chapel. The "REC" – Regional Employment Center requires a street scape which means that buildings are pulled to the edge

of the property line and the adjacent right-of-way will create an environment where pedestrians feel more comfortable walking. He stated that on the concept plan they are showing more of a traditional suburban design where the building is interior to the lot and does not address the right-of-way as prescribed by the "REC" – Regional Employment Center. Mr. Quint stated that knowing that the proposed elevations do not meet the minimum standards required by the zoning Ordinance, staff is recommending denial of the proposed request due to the lack of conformance with both the zoning ordinance and the "REC" - Regional Employment Center's vision that is prescribed. Mr. Quint stated that the vision prescribed by the "REC" - Regional Employment Center does not reflect current market reality. Mr. Quint stated that they are not recommending denial because of the proposed use but because the proposed elevations do not meet the minimum standards that are required for the "REC" - Regional Employment Center. Applicant, Mr. Randy Hullett, 1700 Redbud, McKinney stated that they are proposing to rezone the property to modify the development standards to develop a high quality wedding chapel. They are requesting to move it back on the property so that their guests would have a view of the golf course. Mr. Michael Tamer, 1319 Eagle Bend, Southlake gave a description of the proposed chapel. Mayor Loughmiller called for public comment and there Council unanimously approved the motion by Council were none. member Kever, seconded by Council member Day, to close the public hearing and approve an Ordinance rezoning fewer than 4 acres from "PD" - Planned Development District and "REC" - Regional Employment Center Overlay District to "PD" - Planned Development District and "REC" - Regional Employment Center Overlay District, generally to modify the Development Standards, located on the southwest corner of Van Tuyl Parkway and TPC Drive, with the following special ordinance provisions shall apply: the use and development of the subject property shall conform to the requirements of "PD" - Planned Development District Ordinance No. 2001-02-017, except as follows: wedding chapel/reception hall shall be an allowed use on the subject property; development of a wedding chapel/reception hall on the subject property shall generally conform to the attached concept plan; development of a wedding chapel/reception hall on the subject property shall generally conform to the attached elevations; and the minimum parking requirements for a wedding chapel/reception hall on the property shall conform to the attached concept plan. Ordinance Changing the Name of the Collin County Regional Airport and Approving Naming the City of McKinney's Fixed Based Operation to McKinney Air Center. City Manager Jason Gray stated that based on conversations, staff is recommending that they change the name of the airport from Collin County Regional Airport to McKinney National Airport to provide identity with the actual location of the airport and signify the significant financial contribution that this community has invested in it.

Mr. Gray stated that this agenda item is to name the airport McKinney National Airport and to name the Fixed Based Operations as McKinney Air Center. Council unanimously approved the motion by Mayor Pro-Tem Ussery, seconded by Council member Day, to approve an Ordinance

changing the name of the Collin County Regional Airport to McKinney National Airport and naming the City of McKinney's fixed based operation to McKinney Air Center. Caption reads as follows:

Mayor Loughmiller called for a Public Hearing to Consider/Discuss/Act on a Resolution Authorizing the City Manager to Negotiate an Agreement(s) with a Development Firm(s) for the Redevelopment of City-Owned Properties in the Downtown Area. Director of Planning Michael Quint stated that on May 7, 2013 an item was considered and Council expressed a few issues that they wanted Staff to go back and research. The issues included the appropriate density for downtown, where the future municipal center will be located, if parking demands are being addressed, and can downtown handle the proposed redevelopment center. Mr. Quint stated that staff recommends the future municipal facility be located on some combination of the northern sites and that the final location may be determined at a future date. Mr. Quint stated that from Staff's perspective, there really isn't a parking issue at this time and both the proposals from Zenstar Development and InTown Homes include a parking structure. Mr. Quint stated that the recommended action for tonight is to adopt the Resolution that will allow the City Manager to enter into full negotiations with Zenstar Development and InTown Homes.
