AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, AMENDING THE FISCAL YEAR 2015-2016 ANNUAL BUDGET AND 2016 - 2020 CAPITAL IMPROVEMENT PROGRAM FOR THE PROJECT AWARDED TO THE CITY OF McKINNEY FOR THE TRANSPORTATION ALTERNATIVES PROGRAM (TAP) FOR SAFETY ACCESS TO SCHOOLS PROJECT; AMENDING THE CODE OF ORDINANCES, CITY OF McKINNEY, TEXAS; PROVIDING FOR PUBLICATION OF THE CAPTION OF THE ORDINANCE, EFFECTIVE DATE HEREOF, AND A PENALTY CLAUSE

- WHEREAS, as required by City Charter, the Interim City Manager must prepare an amendment to certain appropriations and expenditures in Fiscal Year 2015-2016 Annual Budget and 2016 2020 Capital Improvement Program; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, THAT:

- Section 1. Pursuant to the City Charter requirements of the City of McKinney, Texas, a Budget Amendment pertaining to Fiscal Year 2015-2016 Annual Budget is hereby authorized and approved.
- Section 2. The budget shall be amended by transferring \$426,695 grant from the Texas Department of Transportation to the Capital Improvement Program Project TR1603, Transportation Alternative Program (TAP) for Safety Access to Schools.
- Section 3. The budget shall be amended by appropriating \$426,695 in the Street Construction Fund for TR1603 Transportation Alternative Program (TAP) for Safety Access to Schools.
- Section 4. This Ordinance shall become effective from and after the date of its final passage and publication as provided by law, and it is accordingly so ordained.
