Applicants for CDBG funding presented as follows:

Hope's Door, represented by Amy Tippetts, is requesting \$10,000 in grant funds for their Intervention and Prevention Project.

Brian Marques of the Community Lifeline Center was seeking funds of (1) \$15,000 for the Emergency Financial Assistance Program and (2) \$35,000 to support the Lifeline Market Expansion.

Stephen Hood of the Wellness Center for Older Adults is asking for \$12,761 to help fund the Gatekeeper Program which benefits McKinney senior citizens in need of housing repair and assistance.

Sara Gilbert, representing GreenPath Debt Solutions, requested grant funds of \$10,00 to support the Family Financial Health Initiative.

Collin County Committee on Aging, represented by Zella Tyson, is asking for funding of \$64,500 to support the Meals on Wheels Program.

Major Paul White of The Salvation Army is seeking funding of \$20,000 for the Emergency Rent and Utilities Program.

The Auxiliary of Medical Center of McKinney was represented by Diane Tubbs.

They are asking for \$5,000 to support a Prescription Assistance Program for elderly lowincome patients leaving the hospital and are in need of prescription drugs.
