AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, AMENDING THE FISCAL YEAR 2015-2016 ANNUAL BUDGET AND THE 2016 – 2020 CAPITAL IMPROVEMENT PROGRAM TO CREATE AND FUND A NEW PROJECT FOR THE STOVER CREEK MASTER DRAINAGE STUDY (DR1645); AMENDING THE CODE OF ORDINANCES, CITY OF McKINNEY, TEXAS; PROVIDING FOR PUBLICATION OF THE CAPTION OF THE ORDINANCE, EFFECTIVE DATE HEREOF, AND A PENALTY CLAUSE

- Section 1. Pursuant to the City Charter requirements of the City of McKinney, Texas, a Budget Amendment pertaining to the Fiscal Year 2015–2016 Annual Budget is hereby authorized and approved.
- Section 2. The budget shall be amended by appropriating \$500,000 to the CIP Project DR1645 Stover Creek Master Drainage Study.
- Section 3. This Ordinance shall become effective from and after the date of its final passage and publication as provided by law, and it is accordingly so ordained.
