- WHEREAS, Ordinance Number 2011-04-016 established a Board of Directors comprised of nine members for the TIRZ and provided that the City Council shall be entitled to appoint a minimum of eight (8) board members to staggered two (2) year terms; and
- WHEREAS, Ordinance Number 2011-04-016 also provides that the City Council shall endeavor to appoint a member of the Planning and Zoning Commission to serve a board term concurrent with such member's Planning and Zoning Commission term.

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

- Section 1. The foregoing recitals are hereby found to be true and correct legislative and factual findings of the City of McKinney, Texas, and are fully incorporated into the body of this Resolution.
- Section 2. The following persons are hereby appointed to as members of the Board of Directors for Reinvestment Zone Number One, City of McKinney, which terms will commence on the 1<sup>st</sup> day of October, 2016:
