Administrator Best reviewed the Consolidated Annual Performance Report (CAPER) that will be presented to City Council on December 6.

This year-end report evaluates activity conducted during the period of October 1 to September 30. Funds and activities were used to meet the CDBG National Objective of primarily benefitting low-to-moderate income persons or households. The City expended \$679,074.54 during this program year, with a minimum of 70% of all funds to benefit low-to-

moderate persons or households. The CAPER is currently under public review.
