THENCE with the east line of said Tract 5 and the west line of said Tract 6, North 00°08'00" East, passing a 1/2 inch iron rod found for reference at 1161.95 feet and continuing for a total distance of 1186.63 feet to a point for corner in the approximate centerline of Baxter Well Road and marking the northeast corner of said Tract 5 and the northwest corner of said Tract 6;
