relationships with Mayor and Council members; complete three projects

per year that make a material difference in the fabric of the community;

regularly communicate role and purpose of CDC; pursue community

outreach; support community groups through funding of projects eligible

for consideration under state law.

Next steps for CDC: regularly review strategic priorities and revise as

needed; continue to discuss and refine role of CDC; continue to examine

role of CDC with City leaders; reformat strategic plan to include

information regarding sequencing and timeframe for achieving objectives;

provide updates to City Manager and Council.
