- 17-982 Oaths of Office. The Oath of Office was administered to the commissioners by City Secretary Sandy Hart.
- 17-983 Election of Officers. Commissioner Hubbard was nominated as Chairman by Commissioner Pedraza. Commissioner Hennie was nominated as Co-Chairman by Commissioner Buettner. The slate of officers was presented for approval by Administrator Best. Commissioners unanimously approved the slate.
- 17-984 Board Orientation and Training. Administrator Best provided an overview of commissioner expectations. The primary function of the Community Grants Advisory Commission is to review grants and deliberate to make funding recommendations based on application content presentations. The Community Support Grant cycle occurs during the Fall and the CDBG cycle occurs in the Spring. The focus tonight will be on the Community Support Grant. Each grant cycle consists of two public hearing sessions and one deliberation meeting. Agencies may make applications for two grants and all requests must be for \$3,000 minimum. Agencies must be a 501(c)(3) for at least one year.
