

LEGAL DESCRIPTION - EAST TRACT (PROPOSED LOT 2)

BEING a 3.416 acre tract of land situated in the Thomas J. McDonald Survey, Abstract No. 576, Collin County, Texas; said tract being part of that certain tract of land described in General Warranty Deed With Vendor's Lien to BVJV Watauga, LP recorded in County Clerk's File No. 20070713000965140 of the Official Public Records of Collin County, Texas; said 3.416 acre tract being more particularly described as follows:

BEGINNING at a 1/2-inch iron rod found for corner in the centerline of McLarry Drive (an undedicated right of way), said point also being the southeast corner of said BVJV Watauga tract and the northeast corner of that certain tract of land described in Warranty deed With Vendor's Lien to Howard Hamilton and Alexander R. Modelski recorded in County Clerk's File No. 94-0025396 of the said Official Public Records and in the west line of that certain tract of land described in General Warranty Deed to the City of McKinney recorded County Clerk's File No. 20070727001038430 of the said Official Public Records;

THENCE, South 88 degrees, 46 minutes, 23 seconds West, departing the centerline of said McLarry Drive and along the south line of said BVJV Watauga tract and the north line of said Hamilton and Modelski tract, at a distance of 138.49 feet passing the northeast corner of Lot 1, Block A, New Holland Addition, an addition to the City of McKinney, Texas according to the plat recorded in Cabinet K, Page 203 of the Plat Records of Collin County, Texas, continuing along said south line of BVJV Watauga tract and the north line of said Lot 1, Block A, in all a total distance of 270.01 feet to a point for a corner;

THENCE, North 00 degrees 41 minutes 17 seconds West, a distance of 510.06 feet to a point for a corner in the northwest line of a Waterline Easement to City of Irving by Collin County Court Cause #002-939-00;

THENCE, North 71 degrees 52 minutes 15 seconds East, with the northwest line of the said easement, a distance of 282.73 feet to a point for a corner in the center of McLarry Road (an undedicated right of way) and the;

THENCE, South 00 degrees 51 minutes 07 seconds East, with the center of McLarry Drive and the west line of the said City of McKinney tract, a distance of 94.15 feet to a point for a corner;

THENCE, South 00 degrees 41 minutes 17 seconds East, continuing with the center of McLarry Drive and the west line of the said City of McKinney tract, a distance of 498.12 feet to the Point of Beginning, and Containing 148,813 square feet or 3.416 acres of land.
