McKINNEY CAPITAL IMPROVEMENT PROGRAM OVERVIEW

What is the CIP?

The Capital Improvement Program (CIP) is a five-year plan for major capital projects, including all probable funding sources for the period. The plan provides a working blueprint for sustaining and improving the community's infrastructure.

How it Works

Each year the City Council reviews the CIP project list and funds the first year of the plan as part of the annual budget process.





What are the Benefits?

- Synchronizes capital and operating budgets
- Links the City's long-term goals and objectives with financial capacity
- Identifies, prioritizes, and optimizes the financing of projects.
- Informs the public about the City's investment in infrastructure







McKINNEY CAPITAL IMPROVEMENT PROGRAM OVERVIEW

How are Projects Selected?

Through City staff rankings, direction from City Council, and coordination with master plans.





CIP INFRASTRUCTURE PLANNING AND THE MCKINNEY ETJ

What has Changed?

- Recent changes in state law (Senate Bill 6 / Chapter 43 of the Local Government code) have modified the procedures for carrying out municipal annexations (*Effective December 1, 2017*).
- These changes in procedure have a significant impact on the ways in which Texas city's approach and are able to successfully complete municipal annexations.

What Does this Mean for McKinney?

In light of SB 6, **Capital Improvement Planning** will become even more important as a growth-influencing tool for McKinney in order to protect the long-term health and vitality of city services, development patterns and fiscal stability.



Limit Opportunities for Potential ETJ Development to Benefit from City Infrastructure




Leverage Infrastructure Planning and Construction to Encourage Annexation Agreements in Advance of Development


