Please find attached the Preliminary-Final Plat for Trinity Falls Planning Unit 3 Phase 4. As a part of submitting this Preliminary-Final Plat, we would like to retract this area from the Trinity Falls Planning Unit 3 Preliminary-Final Plat dated 2/16/2016 (City Project No. 15-263PF). In addition, we would like to request a variance to Subpart B, Chapter 142, Article IV, Section 142.99 – 3 of the City of McKinney Code of Ordinances to allow Lots 53-62 in Block G to front common area G-3. The subject property is located at the northeast corner of CR 206 and Trinity Falls Parkway. Planning Unit 3 Phase 4 is bounded by existing Trinity Falls Parkway to the south, existing Sweetwater Cove to the east, future Planning Unit 3 Phase 3 to the North, and existing CR 206 to the west. The site is +/-53.34 acres in size, contains 241 lots and 37 common areas for landscaping, and is located in the City of McKinney Extraterritorial Jurisdiction.
