AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS AUTHORIZING A CERTAIN BUDGET AMENDMENT PERTAINING TO THE FISCAL YEAR 2018-2019 BUDGET AND THE 2019-2023 CAPITAL IMPROVEMENTS PROGRAM TO PROVIDE FUNDS FOR WHITE AVE MEDIAN IMPROVEMENTS PROJECT; AND PROVIDING FOR AN EFFECTIVE DATE HEREOF

WHEREAS, as required by the City Charter, the City Manager has prepared an amendment to certain appropriations and expenditures/expenses in the 2018-2019 Budget and the 2019-2023 Capital Improvements Program and submitted same to the City Council for its approval and a true and correct copy is attached.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, THAT:

- Section 1. Pursuant to the City Charter requirements of the City of McKinney, Texas, the Fiscal Year 2018-2019 Budget Amendment as attached is hereby authorized and approved.
- Section 2. The budget shall be amended by transferring \$34,000 from Median Escrow Zone J to the Park Construction Fund.
- Section 3. The budget shall be amended by appropriating \$34,000 in the Parks Construction Fund for White Ave Median Improvements project (PK1735).
- Section 4. This Ordinance shall become effective from and after the date of its final passage and publication as provided by law, and it is accordingly so ordained.
