### AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS AMENDING THE FISCAL YEAR 2018-2019 ANNUAL BUDGET AND 2019 – 2023 CAPITAL IMPROVEMENT PROGRAM TO PROVIDE FUNDS FOR PARK IMPROVEMENTS

- WHEREAS, as required by City Charter, the City Manager has prepared an amendment to certain appropriations and expenditures in Fiscal Year 2018-2019 Annual Budget and the 2019-2023 Capital Improvement Program; and
- **WHEREAS,** the City Manager submitted same to the City Council of the City of McKinney, Texas for its approval and a true and correct copy is attached.

# NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, THAT:

- Section 1. Pursuant to the City Charter requirements of the City of McKinney, Texas, a Budget Amendment pertaining to Fiscal Year 2018-2019 Annual Budget is hereby authorized and approved.
- Section 2. The budget shall be amended by transferring \$2,000,000 of Parkland Dedication Zone 3 Funds to the Parks Construction Fund.
- Section 3. The budget shall be amended by appropriating \$2,000,000 in the Park Construction Fund to set up new CIP project PK1906 for the Craig Ranch Soccer Complex and Park Improvements.
- Section 4. This Ordinance shall become effective from and after the date of its final passage and publication as provided by law, and it is accordingly so ordained.
