Funds and activities as required, were predominately used to meet the CDBG National Objectives of benefiting low-to-moderate income persons, areas and households. The public had opportunity to participate in the process through the application process, public hearings, focus groups and community forums, including a public comment period. The report provides a snapshot of how the funds have been used. Mayor Fuller called for public comments and there were none. Staff requests Council's direction to move forward with the original plan and leave Herndon Street open. We will continue to work with Thomason Tire to make adjustments in order for the large trucks to have easier access to their facility. Herndon Street will close down during construction but once construction is complete, it will be opened back up. Council approved the motion by Council member Shemwell, seconded by Council member Elliott, to approve the design of the Downtown Parking Garage, generally located on the northeast corner of Chestnut Street and Virginia Street with a vote of 5-1-0, Mayor Pro Tem Rogers voting against.

The study may show that we do not
