FEBRUARY 5, 2019

The City Council of the City of McKinney, Texas met in regular session in the McKinney City Hall Council Chambers at 222 N. Tennessee Street, McKinney, Texas, on February 5, 2019 at 6:00 p.m.

Mayor Fuller called for the following Regular Agenda Items:

Chief Financial Officer Mark Holloway requested Council to adopt the Reports and introduced David Coleman of auditing firm BDK, LLP to share information regarding the audit and final unmodified opinion of the City of McKinney financial statements. The audit was issued two weeks ahead of schedule compared to the previous year. There were no significant deficiencies or material weaknesses concerning State and Federal compliance. The City is expected to again earn the Government Finance Officers Association Award for Achievement in Financial Reporting, which would be the 35th consecutive year of receiving the honor. Mr. Coleman stated the City of McKinney is well-managed evidenced by the work of the Accounting staff to help produce the audit in a timely manner. Council unanimously approved the motion by Mayor Pro Tem Rath, seconded by Council Member Branch, to approve the Comprehensive Annual Financial Report (CAFR) and the Federal/State Single Audit Reports for the Fiscal Year Ended September 30, 2018.

Director of Planning Jennifer Arnold stated staff met with applicant concerning the request to rezone the property of approximately 24 acres and supports the request. Additionally, it received favorable recommendation from the Planning & Zoning Commission.

Greg Nelson, on behalf of the property developer Sentinel Capital, stated plans for the area consist of food and service retail and industrial; there are currently no tenants for the property. There were no additional requests to speak during the public hearing. Council unanimously approved the motion by Council Member Rogers, seconded by Council Member Chuck Branch, to close the public hearing and approve the request to Rezone the Subject Property from "AG" - Agricultural District to "LI" - Light Industrial District and "C3" - Regional Commercial District, Located on the Southeast Corner of Couch Drive and FM 546 (Harry McKillop Boulevard), and Accompanying Ordinance. Director of Planning Jennifer Arnold stated this site plan was presented to

Council in October 2018 due to the variances requested by the applicant.

The variances are related to the orientation and screening of bay doors as

well as overnight parking. While staff can approve the façade plan which was also presented in October 2018, it recommends denial of the site plan variance requests (unchanged from the October 2018 meeting) due to the same concerns related to bay doors in view of public right of way and overnight parking in public view without screening. In consideration of aesthetic appeal, City Ordinance does not allow by right for bay doors or overnight parking to be in public view. Staff is requesting a "living screen" from the approved plant list to block the view of the doors which is consistent with the approach of other auto dealers. A living screen at the Mercedes dealership was noted. Vehicle maintenance service is intended for the facility without body repair work. Grayson Hughes, with Big Red Dog Engineering of Dallas, spoke on behalf of the applicant, stated the applicant will provide ornamental trees and shade trees along street frontages and parking areas and is currently meeting the general landscape requirements excepting the masonry screening requirements for the bay doors and overnight parking. Several Council Members commended the applicant on the second effort to obtain approval for the plan. There were no other requests to speak during the public hearing. Council unanimously approved the motion by Council Member Rogers, seconded by Council Member Branch, to close the public hearing. Council continued discussion on the item including concern for favoring certain businesses over others, ensuring to establish fair expectations applicable to all, deliberation on how much visibility is possible without screening and how much screening should be required, and potential approval with modifications to the request. Council approved the motion by Council Member Rogers, seconded by Council Member Elliott, to approve the Site Plan for an Automobile Service and Repair Facility (Porsche McKinney), Located on the Northeast Corner of State Highway 121 (Sam Rayburn Tollway) and Hardin Boulevard with adherence to staff requirements for living screens, with a vote of 6 to 1, Council Member Shemwell voting against.

There were no requests to speak during the public hearing. Council unanimously approved the motion by Mayor Pro Tem Rath, seconded by Council Member Rogers, to Close the public hearing and approve the Specific Use Permit Request for a Private Street Subdivision (Paradiso Valle), Located Approximately 1,000 Feet South of Gray Branch Road and on the East Side of Ridge Road, and Accompanying Ordinance. The \$40,000 sculpture of hammered copper and steel will be located in the northeast quadrant of Mitchell Park, will be 13 feet tall with a 9-foot opening between the two concrete bases, and is the third piece of City-sponsored public art after the mural near Cadillac Pizza restaurant and the mosaic at the Chestnut Street garage. Former Council Member Don Day was in attendance and received thanks for his family's 50% contribution to the project to satisfy the private fund match required to obtain the Arts Commission grant of public funds. Council unanimously approved the motion by Council Member Shemwell, seconded by Council Member Rogers, to approve the Resolution Authorizing the City Manager to Execute, and Amend as Necessary, a Contract with Ai Qui Hopen, Sculptor, for the Fabrication and Installation of Unity Arch at Mitchell Park. City Attorney Mark Houser stated the Special Charter Amendment Election will contain two ballot items relating to Recall Petitions and Recall Elections. Mr. Houser confirmed the order of the ballot will be election of Council Members followed by Bond, then Charter Amendment.

Mayor Fuller recessed the meeting into Executive Session at 7:10 p.m., in accordance with the Texas Government Code:

A. Section 551.071(2) Consultations with Attorney on any Work Session, Special Session, or Regular Session agenda item requiring confidential attorney/client advice necessitated by the deliberation or discussion of said items (as needed).

Mayor Fuller reconvened the meeting at 7:18 p.m.

Council continued discussion on the Charter Amendment Election, expressing concern for potentially 2% of the City's population to influence a recall, potentially modifying or extending the petition deadline rather than decreasing the petition signature requirement, the difference between the ability to recall an election versus the requirements for forcing removal from office, aligning the petition requirements with neighboring cities, and encouraging greater voter participation. City Attorney Houser stated the requirement for 1,000 signatures is still greater than most surrounding cities also clarifying the petition is to recall the election and the election to remove a member would still require a majority of citywide vote. Council approved the motion by Mayor Pro Tem Rath, seconded by Council Member Rogers, to approve the Ordinance Calling for the May 4, 2019 Special Charter Election with a vote of 6 to 1, Council Member Shemwell voting against. Ordinance captions read as follows:
