## **CITY COUNCIL WORK SESSION**

## **FEBRUARY 19, 2019**

The City Council of the City of McKinney, Texas met in work session in the McKinney City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on February 19, 2019 at 3:00 p.m.

Council Members Present: Mayor George C. Fuller, Mayor Pro Tem Tracy Rath, and Council Members Scott Elliott, Rainey Rogers, Chuck Branch, and La'Shadion Shemwell. Council Member Charlie Philips was not present at the Call to Order but joined at 3:09 p.m.

Mayor Fuller called the meeting to order at 3:02 p.m. after determining a quorum of the Council was present.

Mayor Fuller called for the Discussion of Regular Agenda Items of the upcoming City Council regular meeting on February 19, 2019 at 6:00 p.m.

Director of Planning Jennifer Arnold was called to speak regarding Council questions related to agenda item numbers 18-0158Z2 and 18-0159Z2.

Mayor Fuller called for discussion of the following Work Session items with no action taken:

**19-0125** Update on Bike the Bricks Special Event Survey

**19-0126** Update on the Texas Main Street Program

Mayor Fuller called for Council Liaison Updates.

Council Member Charlie Philips stated the McKinney Main Street board recently completed a public survey and recognized staff Amy Rosenthal and Main Street Board member Jim Smith who were present at the meeting. Council Member Philips encouraged the Council to review the findings of the survey regarding activities in Downtown McKinney.

Council Member Scott Elliott stated Director of Parks & Recreation Michael Kowski provided a lengthy update for the Parks & Recreation Advisory Board in February since there was no board meeting the previous month. Council Member Elliott commended Director Kowski and the Parks & Recreation for the impressive number of projects taking place and the recovery work to improve Bonnie Wenk park from recent flooding; commended the vision of Parks department on Parks & Recreation portion of the bond committee.

Council Member La'Shadion Shemwell said the Parks & Recreation department is doing an amazing job with the City; provided an update on the McKinney Housing Auth project on Tennessee Street near Highway 380, stating the old buildings have been knocked down and looks forward to the future progress of construction.

Mayor Pro Tem Tracy Rath stated the McKinney Main Street board conducted a strategic planning meeting during the last week with robust discussion of downtown surveys and written comments; the filming of a "Hello from McKinney Main Street" message will be shown at a national conference in Seattle, Washington, in March 2019. The message was taped on the steps of the old Courthouse (MPAC) using drones.

Mayor Fuller announced the resignation of Jason Burress from the McKinney Economic Development Corporation, where he served as Chairman; City Council will appoint new member soon; thanked Mr. Burress for his valuable civic work and noted he will be missed. Mayor Fuller mentioned McKinney Police Officer Tom Turpin who was
