

**CITY COUNCIL REGULAR MEETING**

**FEBRUARY 19, 2019**

The City Council of the City of McKinney, Texas met in regular session in the McKinney City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on February 19, 2019 at 6:00 p.m.

Council Members Present: Mayor George C. Fuller, Mayor Pro Tem Tracy Rath, and Council Members Charlie Philips, Scott Elliott, Rainey Rogers, Chuck Branch, and La'Shaddon Shemwell.

Mayor Fuller called the meeting to order at 6:00 p.m. upon determining a quorum of the Council was present.

Mayor Fuller called for the Invocation and recital of the Pledge of Allegiance. The Invocation given by Minister Bill Rosnett of Northwest Christian Church. Director of MPAC & McKinney Main Street Program Amy Rosenthal announced upcoming events to be held in conjunction with McKinney Black History Remembrance: Portrait unveiling at MPAC on February 23, 2-4 p.m. for recognition of education and civic leaders; and February 24 at 4 p.m. the

documentary *We must Honor, We must Teach* which featuring the voices of many McKinney leaders.

City staff supports Council approval and do not share the same concerns for the adjacent property owners due to existing zoning provisions for safety and separation of the properties. Casey Gregory was present on behalf of the applicant (Sanchez & Associates) in support of the request, noting the general intended uses of the property include commercial and office with no specific end users currently identified, and maintaining the existing cell tower and landscaping buffers. Council unanimously approved the motion by Mayor Pro Tem Rath, seconded by Council Member Rogers, to close the public hearing and approve the Request to Rezone the Subject Property from "AG" - Agricultural District to "C2" - Local Commercial District, Located at the Southwest Corner of Virginia Parkway and Hardin Boulevard. Mayor Fuller again called for Citizen Comments.

Desiree Juarez, 1701 N Church St, McKinney 75069, thanked the Council on behalf of the North Texas Job Corps (NTJC) Student Association for the meaning recognition and invitation to participate in the City Council meeting.

Mayor Fuller called for Council and Manager Comments.

Council Member Philips recognized NTJC Director Will Stinson for attending and the service of the NTJC Culinary Department for providing the Council meal; commented on the memorial service honoring Officer Tom Turpin and thanking the men and women of McKinney law enforcement for their service to the City.

Council Member Elliott commented on Deborah Kilgore, Director of Collin County Historical Museum who was recently placed in hospice care, requesting prayers on behalf of her and her family. Mr. Elliott recognized Mrs. Kilgore's personal friendship and service to McKinney.

Council Member Rogers commented on the upcoming election for Council members, thanking those who entered the election and stating he does not have an opponent.

Council Member Shemwell extended well wishes to Deborah Kilgore and her family and condolences for the loss of Officer Tom Turpin. Council Member Shemwell encouraged everyone to support police officers, fire fighters, and other emergency responders for the work difficult they do in the City and encouraged the NTJC Student Government Association for their attendance and participation in the meeting.

Council Branch thanked the NTJC group for attending the meeting, stating it's a pleasure to see them. Council Member Branch commented on his service on Council and his intention to not run for re-election, his appreciation and gratitude for getting things done and the opportunity to meet new people.

City Manager Paul Grimes thanked Mayor Fuller for the kind and moving words at the funeral service of Officer Tom Turpin and representing the City well; encouraged

citizens to go online to take the Citizen Satisfaction Survey; reminded the public of the City Council, Bond and Charter Amendment election on May 4, 2019 and information about the election available online at [www.mckinneytexas.org/vote](http://www.mckinneytexas.org/vote).

Mayor Fuller announced a web site created by the McKinney Chamber of Commerce <https://formymckinney.com> with additional information about the bond and various Council members will participate in public engagement activities for the bond. Mayor Fuller mentioned the passing of his friend Officer Tom Turpin stating that it's easy to speak well of someone who served the City so well for more than 27 years and that Officer Turpin will be greatly missed. Mayor Fuller stated he was saddened to learn about the condition of Deborah Kilgore, who has been a staple of the City for many years.

Council did not meet in Executive Session or take action on Executive items.

Council unanimously approved the motion by Council Member Shemwell, seconded by Council Member Elliott, to adjourn. Mayor Fuller adjourned the meeting at 7:02 p.m.
