# **CITY COUNCIL REGULAR MEETING**

## **MARCH 5, 2019**

The City Council of the City of McKinney, Texas met in regular session in the McKinney City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on March 5, 2019 at 6:00 p.m.

Council Present: Mayor George C. Fuller, Mayor Pro Tem Tracy Rath, and Council Members Charlie Philips, Scott Elliott, Rainey Rogers, Chuck Branch, and La'Shadion Shemwell.

Mayor Fuller called the meeting to order at 6:00 p.m. upon determining a quorum of the Council was present.

Mayor Fuller called for the Invocation and recital of the Pledge of Allegiance.

The Invocation was given by Avery Figueroa of Cornerstone Ranch. The Pledge of Allegiance was led by Adam Eck of Cornerstone Ranch.

Mayor Fuller called for the following Information Sharing Items:

Mayor Fuller was joined by Avery Figueroa, Adam Eck, and Jayme Bajula of

Mayor Fuller called for discussion of the item pulled from the Consent Agenda.

Assistant to the City Manager Trevor Minyard and McKinney resident Jimmy Teeling answered questions by Council concerning the intent of the program and barriers to participation affecting those excluded by the proposed program eligibility requirements. Council discussed how to include potential candidates who are "high school aged" but not public school students, such as homeschool students and early graduates; potential human resource issues related to establishing age restrictions or ranges for program participants; and inviting an overwhelming pool of candidates by expanding eligibility to college students.

Council unanimously approved the motion by Council Member Rogers, seconded by Council Member Shemwell, to approve the Resolution Establishing a McKinney Community Internship Program for the Summer of 2019, with the following inclusions by Council: "The City Manager shall endeavor to provide student internships to residents of McKinney, Texas who are full-time high school students, or full-time college students, generally under the age of 19, but not exclusively thereto." Resolution caption reads as follows:

Mayor Fuller called for the remaining regular agenda items:

of an ill McKinney Police Officer. Mayor Fuller also expressed gratitude Collin County

Judge Chris Hill for speaking kindly of the City of McKinney as one of the many cities

contributing to the success of Collin County.
