MARCH 19, 2019

The City Council of the City of McKinney, Texas met in work session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on March 19, 2019 at 3:00 p.m.

Council Member Charlie Philips announced the Arts in Bloom event will take place April 12, thanking the Main Street Board for their work of coordinating the event and supporting Downtown McKinney.

Council Member Scott Elliott acknowledged the work of the Parks & Recreation department and advisory board, noting they are "very busy" working to implement the plans for the next five years of development. Mr. Elliott said the previously held McKinney Community Awards Celebration was a fabulous night and mentioned the upcoming Volunteer McKinney Awards Celebration on the evening of March 21. Mr. Elliott said the volunteer efforts of many people all over the city is a part of what makes McKinney great.

Council Member Shemwell acknowledged the passing of Deborah Kilgore, the Curator of the Collin County Historical Museum. Mr. Shemwell recognized her service to the city of McKinney. Council Member Branch thanked Officer Lee and several residents who helped pick up numerous photographs that spilled on the ground at Virginia Street and Ridge Road. The pictures appeared to be high school and middle school pictures. Mr. Branch hopes to locate the apparent owner, Rocky Matthews of Ohio, and asked for prayers in the effort.

Mayor George Fuller announced Dr. Gere' Feltus joined the McKinney Economic Development Corporation (MEDC) board earlier in the day, stating she will be a fantastic addition. Departing Board Chairman Jason Burress was also recognized for his service to MEDC. Mayor Fuller also acknowledge Deborah Kilgore and encouraged the public to visit the *McKinney Then & Now* exhibit at the Collin County Historical Museum. The exhibit is one of the final projects Mrs. Kilgore worked to offer at the museum.
