CITY COUNCIL REGULAR MEETING

MARCH 19, 2019

The City Council of the City of McKinney, Texas met in regular session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on March 19, 2019 at 6:00 p.m.

Development Engineering Manager Matt Richardson, the request to abandon a "sliver" of right of way west of McDonald Street adjacent to Chestnut Square. Chestnut Square is the only property owner adjacent to the land to be abandoned. It is a small portion of land left over from the TxDOT project to build Highway 5 in the 1950's. The city will retain an easement on the property for sanitary sewer maintenance. Representatives of Chestnut Square were present at the meeting in support of the item but did not formally address the Council.

There were no requests to speak during the Public Hearing.

Council unanimously approved the motion by Council Member Branch, seconded by Council Member Rogers, to close the public hearing and approve a Right-of-Way Abandonment of a Portion of McDonald Street, Located West of McDonald Street and North of Anthony Street, and Accompanying Ordinance. Ordinance caption reads as follows:

Director of Planning Jennifer Arnold stated the request is to rezone approximately 24 (twenty-four) acres for constructing employment mixed warehouse-office of an industrial related uses. Staff supports the request as other nearby property has been rezoned for similar purposes in recent years, and the Planning & Zoning Commission also supports the request. The applicant was present in support of the request but did not formally address Council.

Amin Bata, 14902 Preston Rd #902, Dallas 75254, owner of property adjacent to the subject tract, spoke in favor of the item, also offering a portion of his property for staff and council to consider joint curb cuts with the property and reciprocal cross access between the two properties.

There were no other requests to speak during the Public Hearing.

Council unanimously approved the motion by Council Member Branch, seconded by Council Member Elliott, to close the public hearing and approve the Request to Rezone the Subject Property from "AG" - Agricultural District to "LI" - Light Industrial District, Located Approximately 280 Feet West of State Highway 5 (McDonald Street) and on the North Side of Wilmeth Road, and Accompanying Ordinance. Affordable Housing Administrator Cristel Todd resolution is for the reconstruction of a substandard home which was occupied by an elderly low-income household. The recommended contractor was one of two bids received and falls within the project budget, which is funded by grants. Mrs. Todd stated approximately \$114,000 (one hundred fourteen thousand) will remain in the budget after the completion of the project.

Transportation Engineering Manager Matt Tilke stated the Safe Routes to School Program is funding to assist with infrastructure and safety related devices within two miles of a school to support children getting to school.

Council unanimously approved the motion by Council Member Shemwell, seconded by Council Member Branch, to approve a Resolution Authorizing the City Manager to Apply for and Accept, if Awarded, Grant Funding Through the Texas Department of Transportation 2019 Transportation Alternatives/Safe Routes to Schools Program. Capital Improvement Project Manager Nick Ataie stated a Transportation Development Credit (TDC) is a state credit which can be earned by developing programs in areas such as air quality, land use strategies, education and outreach. The city has accumulated nearly \$4,000,000 (four million) and sought recommendations from the Regional Transportation Council of the North Texas Council of Governments on projects to secure additional federal funds for completion. The TDCs will be used to offset the twenty percent cost matching requirements for federal funding on the project. Mr. Ataie stated engineering for the project is scheduled for the year 2021 and construction in 2023, with requests to move the project to sooner. Approximately \$736,000 (seven hundred thirty-six thousand) of the TDCs will be utilized for the project.

Council unanimously approved the motion by Council Member Shemwell, seconded by Council Member Branch, to approve a Resolution Authorizing the City Manager to Enter into an Agreement with the Regional Transportation Council for Award of Transportation Development Credits for Improvements to East Louisiana Street from State Highway 5 to Throckmorton Street. Resolution caption reads as follows:

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH THE REGIONAL TRANSPORTATION COUNCIL FOR AWARD OF TRANSPORTATION DEVELOPMENT CREDITS FOR IMPROVEMENTS TO EAST LOUISIANA STREET FROM STATE HIGHWAY 5 TO THROCKMORTON STREET

Mayor Fuller called for Citizen Comments. There were no requests to speak. Council Member Rogers recognized and invited youth members of the visiting Boy Scouts group, Asher Clevenger and Caleb Clevenger, to speak to Council. The two boys stated their names and said hello to Council.

Mayor Fuller called for Council and Manager Comments.

Council Member Elliott spoke on the passing of Deborah Kilgore, Curator of the Collin County Historical Museum. A memorial for Mrs. Kilgore was held at the Museum on March 17, and Mr. Elliott read this poem, attributed as a Native American prayer, in her honor:

I give you this one thought to keep,

I am with you still. I do not sleep.

I'm one thousand winds that blow

And the diamond in the snow;

I am sunlight on ripened grain,

And the gentle autumn rain.

When you awaken in the morning's hush,

I am the swift uplifting rush

Of quiet birds and circle of light

In the soft stars that shine at night.

Do not think of me as gone.

I'm with you still in each new dawn.

Mr. Elliott noted his friendship with Mrs. Kilgore and appreciation for her depth of research as a Curator. He encouraged the public to visit the *McKinney Then & Now* exhibit at the museum, one of the final contributions by Mrs. Kilgore, and thanked the Museum for the memorial, and extended his prayers to her family.

Council Member Rogers announced the March 10 birth of his seventh grandchild, Max Rogers, in Houston, Texas.

Council Member Shemwell acknowledged the visitors in the audience, thanking them for attending the meeting, especially the young people who might have been attending a meeting for the first time. Mr. Shemwell shared words of encouragement stating learning about and engaging in local government is how "we change our community...how we change the world."

Council Member Branch had no comments, except to thank the audience for attending the meeting and wish everyone a great night.

Mayor Pro Tem Rath Council Member Philips had no comments.
