Mr. Shelton updated the Board on the following items: the Craig Ranch resort style Hotel is being finalized, adding many features McKinney currently does not offer like a lazy river resort pool, in the downtown garage the city will be adding cameras for security, Farmers Market has moved back to Chestnut Square, the City signed a letter of intent to support the building of a new 2000 seat performing arts center, the city is in the process of contract to

design improvements downtown which may include a pedestrian area.

Mr. Shelton reviewed the Bond Election with the board and there is not

tax increase with the bonds.

Ms. Rosenthal updated the Board on Bike the Bricks, McKinney City Council decided that the City and Main Street are no longer able to support the event in Downtown McKinney. The board discussed. The KPI dashboard is available on the city website and is a good source of progress for Main Street. With the cancellation of Bike the Bricks, Ms. Rosenthal suggested a subcommittee to determine possibilities for a new festival or smaller events that Main Street could support. Ms. Rosenthal discussed the possibility for a secret shopper program, the Board discussed, Mr. Anderson will put together a recommendation to the Board. Ms. Rosenthal thanked the Board for their support at Krewe of Barkus, specifically Jolie Williams and also the Main Street staff.
