### **CITY COUNCIL REGULAR MEETING**

#### **APRIL 2, 2019**

The City Council of the City of McKinney, Texas met in regular session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on April 2, 2019 at 6:00 p.m.

Council Present: Mayor George Fuller, Mayor Pro Tem Tracy Rath, and Council Member Charlie Philips, Scott Elliott, Rainey Rogers, and La'Shadion Shemwell.

Council Member Chuck Branch was absent.

City of McKinney Staff Present: City Manager Paul Grimes, Deputy City Manager Jose Madrigal, Assistant City Manager Barry Shelton, Assistant City Manager Steve Tilton, Assistant to the City Manager Trevor Minyard, City Attorney Mark Houser, Director of Planning Jennifer Arnold, Planning Manager Samantha Pickett, Assistant Director of Public Works Paul Sparkman, Police Officer Bruno Siqueira, City Secretary Intern Cayla Simpson, and City Secretary Empress Drane.

Mayor Fuller called the meeting to order at 6:00 p.m. upon determining a quorum of the Council was present; then called for the Invocation and the Pledge of Allegiance.

The Invocation given by Bruce B. Miller, Senior Pastor at Christ Fellowship.

The Pledge of Allegiance was led by the 1<sup>st</sup> Robotics Club 6369 of McKinney: Vernon Gomez, Kristie Talley, Madeleine Mott, John Salazar, Angelo Cervantes and Eli Harden, and team coaches Mary Mobley and Jason Bolen.

After the Pledge, the robotics team provided a demonstration of a competition robot and shared information about the group, which is compromised of students for all three McKinney high schools and one home school student. The team participates in several competitions, has social media presence on multiple platforms including Instagram, Facebook, YouTube, and encourages new members to join them. Sponsors for the team include Raytheon, Emerson, Texas Instruments, BestBuy and the Camozzi Group.

After discussion of qualifications of both nominee and polling of Council members, Council unanimously approved the motion by Council Member Rogers, seconded by Council Member Shemwell, to approve the appointment of Carl Smith as a New Member to the Historic Preservation Advisory Board (HPAB). Mr. Smith will serve a partial term expiring September 30, 2020.

Mayor Fuller again called for Citizen Comments. There were no other requests to speak to Council.

Council Member Shemwell recognized a homeless individual named Gary who recently passed away and the many citizens of McKinney who offered him assistance; acknowledged different people are homeless for different reasons.

City Manager Paul Grimes mentioned the recent hail storm and announced the city Outdoor Warning Siren System serves to notify people of potential hazards beyond just tornadoes; warned of potential issues related to door-to-door solicitors of home repair work after the storms and reminded residents that ask to see the required city-issued permit. All roofing projects also require a permit visible from the street. Mr. Grimes encouraged everyone to use the city website for additional information.

Mayor Fuller, Mayor Pro Tem Rath and Council Members Philips, Elliott, and Rogers had no comments.

There was no Executive session.

Council unanimously approved the motion by Council Member Shemwell, seconded by Council Member Scott Elliott, to adjourn. Mayor Fuller adjourned the meeting at 6:52 p.m.
