ORDINANCE NO. 2019-05-033

AN ORDINANCE OF THE CITY OF MCKINNEY, TEXAS CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE BOND ELECTION HELD MAY 4, 2019

WHEREAS, an election was held in the City of McKinney, Texas on the 4th day of May, 2019, for the purpose of submitting certain propositions for the issuance of bonds to the resident electors of the City; and

WHEREAS, it is hereby found and determined that notice of the election was duly given in the form, manner and time required by law, and said election was in all respects legally held and conducted in accordance with applicable laws of the State of Texas and the proceedings calling and governing the holding of such election; and

WHEREAS, the returns of said election have been duly and legally made and submitted to the City Council for canvassing, and a tabulation of the returns for each polling place and for early voting, as canvassed and tabulated by this governing body and shown in **Exhibit A** attached hereto, reflect that the total sum of votes counted "FOR" and "AGAINST" the proposition submitted were as follows:

THE ISSUANCE OF \$91,000,000 GENERAL OBLIGATION BONDS FOR PARKS AND RECREATION FACILITIES AND THE LEVYING OF A TAX IN PAYMENT THEREOF

"FOR" 4,322 votes

"AGAINST" 2,515 votes

CITY OF MCKINNEY, TEXAS PROPOSITION D

THE ISSUANCE OF \$34,000,000 GENERAL OBLIGATION BONDS FOR PUBLIC WORKS FACILITIES AND THE LEVYING OF A TAX IN PAYMENT THEREOF

"FOR" 4,285 votes

"AGAINST" 2,509 votes

CITY OF MCKINNEY, TEXAS PROPOSITION E

THE ISSUANCE OF \$100,000,000 GENERAL OBLIGATION BONDS FOR STREET IMPROVEMENTS INCLUDING SIDEWALK, ALLEY, AND OTHER TRAFFIC FLOW IMPROVEMENTS AND THE LEVYING OF A TAX IN PAYMENT THEREOF

"FOR" 4,905 votes

"AGAINST" 1,933 votes

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS:

<u>SECTION 1:</u> All of the recitals contained in the preamble of this ordinance are found to be true and are adopted as findings of fact by this governing body and as part of its judgment.

SECTION 2: It is further found and determined that the results of the election are as canvassed and tabulated in the preamble hereof and as summarized in *Exhibit A* attached hereto, and, a majority of the resident qualified electors voting at said election having voted in favor of the propositions lettered A, B, C, D, and E, the City Council is hereby declared to be authorized and empowered to issue the bonds on behalf of the City in the amount and for the purposes stated in said propositions, lettered A, B, C, D, and E, all as more fully set forth and identified above and in the proceedings calling said election.

<u>SECTION 3:</u> The City Secretary is hereby authorized and directed to make the appropriate entries of information appearing in tabulation of precinct results shown in *Exhibit A* attached hereto in the election register maintained by the City in accordance with provisions of Section 67.004(b) and Section 67.006 of the Election Code.
