The City Council of the City of McKinney, Texas met in work session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Monday, August 5, 2019 at 3:00 p.m.

Upon determining a quorum of the City Council was present, Mayor Fuller called the meeting to order at 3:00 p.m.

Mayor Fuller called for discussion of the agenda items for the City Council regular meeting to held Monday, August 5, 2019, at 5:00 p.m. There was no discussion regarding those items.

Mayor Fuller called for the following Work Session items:

19-0642 Discuss Alternate Member Appointments to City Boards and CommissionsMayor Fuller called for Council Liaison Updates.

Council Member Charlie Philips stated the McKinney Convention & Visitors Bureau (MCVB) will be proposing to change its public name to "Visit McKinney" which is a popular trend among Convention & Visitors Bureaus.

Council Member Scott Elliott stated the McKinney Community Development Corporation (MCDC) will have multiple member positions open for appointments as long-serving members Kurt Kuehn and David Clarke will be retiring from MCDC. Mr. Elliott stated interviews for the MCDC and Parks & Recreation Advisory Board were recently held, and a large turnout for Parks & Recreation might be attributed to the recent bond approval for various Parks & Recreation projects.

Council Member La'Shadion Shemwell stated he and Council Member Rick Franklin recently attended a ribbon cutting and welcome event for the reconstructed home of Mr. Willie and Mrs. Freddie Mae Sims, which was coordinated by the city Housing Rehabilitation staff utilizing funds from the Community Development Block Grant (CDBG) program. Mr. Shemwell recommended more money should be budgeted toward CDBG for housing rehabilitation and homelessness prevention.

Council Member Richard Franklin expressed support for added more alternate positions to the various city boards and commissions, stating he met with numerous experienced and highly qualified individuals during the interview process. Mr. Franklin thanked everyone who participated in the interviews, encouraging them to remain involved with the city. Mr. Elliott added McKinney enjoys an "embarrassment of riches" when it comes to the willingness of people to serve the city.

Council Member Frederick Frazier stated he enjoyed the boards and commissions interview process, expressing pleasant surprise to the turnout of new applicants, and the quality of the individuals interested in serving.
