AUGUST 5, 2019

The City Council of the City of McKinney, Texas met in regular session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Monday, August 5, 2019 at 6:00 p.m.

Upon determining a quorum of the City Council was present, Mayor Fuller called the meeting to order at 6:01 p.m. and called for the Invocation and recital of the Pledge of Allegiance.

The Invocation given by Minister Henry Moore, of St. Mark Missionary Baptist Church. Pastor Charles Wattley of St. Mark was also in attendance.

The Pledge of Allegiance was led by McKinney Police Honor Guard Team Leader, Officer Tracy Rimpel.

Mayor Fuller called for Information Sharing items.

Mayor Fuller recognized the service of City Secretary Intern, Cayla Simpson, a 2019 graduate of McKinney High School, who earned a 4.32 grade point average and finished in the top 7% percent of her class, ranking #58 overall. Cayla was accepted to attend George Washington University to study law. Cayla was presented a floral bouquet and stood with Mayor Fuller and Council Members, City Manager Paul Grimes and City Secretary Empress Drane for photographs.

Chief Financial Officer Mark Holloway stated the Council would be voting on the Proposed Tax Rate establishing the tax rate ceiling for the fiscal year 2020 at \$0.525170 (which is equal to the budget rate of the previous FY19), and to Schedule Public Hearings. The recommended FY20 budget tax rate will be lower than the

FY2020 ceiling, at \$0.51560. Mr. Holloway submitted the following upcoming important dates related to the Budget process:

- August 9 City Council Budget Work Session
- August 20 Public Hearing #1 on Tax Rate
- September 3 Public Hearing #1 on Budget, and Public Hearing #2 on Tax Rate
- September 17 Public Hearing #2 on Budget & Final Budget Adoption, Ratification of Property Tax Revenue Increase,

Tax Rate Adoption, and Fee / Rate Change Adoption

Mayor Pro Tem Rogers being absent from the meeting, Council members present unanimously approved the motion by Council Member Philips, seconded by Council Member Shemwell, to approve the Fiscal Year 2019-20 Proposed Tax Rate, Take Record Vote and Set Public Hearing and Adoption Dates, as stated: "I move that the City of McKinney propose to adopt a Fiscal Year 2020 Total Tax Rate of \$0.525170, which is higher than the Fiscal Year 2020 Effective Tax Rate of \$0.508664, and call for two public hearings; the first public hearing to be held on August 20, 2019 at 6:00 p.m. and the second public hearing to be held on September 3, 2019 at 6:00 p.m. Further, a record vote on the tax rate adoption will be held on September 17, 2019 at 6:00 p.m. All meetings will be held in the McKinney City Hall Council Chambers at 222 North Tennessee Street, McKinney, TX 75069." 19-0661 Conduct a Public Hearing to Consider/Discuss/Act on a Resolution
Approving the Fiscal Year 2019-20 Community Development Block Grant
(CDBG) Annual Action Plan Recommendations to City Council

Community Services Administrator Shirletta Best stated the Housing & Community Services department conducts a consolidated grants process which includes federal and locally supplied funding. The department works with the Community Grants Advisory Board to consult with non-profit organizations that are eligible for grant administration resources, public services and city-funded programs. Mrs. Best presented the roster of recipient non-profit agencies and city programs under the proposed action plan:

- Court Appointed Special Advocates (CASA) of Collin County, for abused and neglected children;
- Communities in Schools, for youth services at Caldwell Elementary School
- Community Lifeline, for subsistence payments for homelessness prevention assistance program
- Hope's Door New Beginnings, for mental health services counseling for domestic violence victims
- Meals on Wheels Collin County, for senior services providing meals to eligible
 McKinney citizens
- Samaritan Inn, public services / case management services
- Salvation Army, for subsistence payments for emergency financial assistance

- City Grant Administration Program, to support administrative compliance of the CDBG program
- City Housing Rehabilitation Program, for assistance toward eligible home repairs for low- to moderate-income households
- City Landlord Individual Family Tenant (LIFT) Program, for homelessness prevention assistance and services

Mrs. Best stated the fiscal year of the program will begin October 1, 2019; the budget allocation for FY2020 is approximately \$495,000 (four hundred ninety-five thousand); and any FY2019 funds allocated to non-profit agencies and City Grant Administration Program that remain unused on September 30 will carry over to the FY20 City Housing Rehabilitation Program.

Council Member Shemwell restated his sentiments from the earlier Work Session meeting, to increase the allocated budget. He stated the budget should be increased to a minimum of \$1,000,000 (one million) plus any carryover funds, to support the program's provision of services to the community. Mrs. Best noted the funding is based on population, emphasizing the importance of maximal participation in the upcoming 2020 Census; and the program does not lose funding, as long as it satisfies compliance requirements.

Mayor Fuller called for citizen comments concerning Public Hearing. Other than the earlier comments by Jasmine Greeson, there were no additional requests to speak. Council unanimously approved the motion by Council Member Shemwell, seconded by Council Member Frazier, to close the Public Hearing and approve the Resolution for the

Fiscal Year 2019-20 Community Development Block Grant Annual Action Plan Recommendations. Resolution caption reads as follows:

Mayor Fuller called again for Citizens Comments. There were no additional requests to speak.

Mayor Fuller called for Council and Manager Comments.

Council Member Rick Franklin stated he recently attended his first meeting of the McKinney Housing Authority (MHA) at the Newsome Homes apartment complex (reconstructed in 2017), complimenting the MHA's management and partnership with the McKinney Housing Finance Corporation for that development, as well as the Merritt Homes reconstruction project currently underway.

Council Member Frederick Frazier stated a candlelight vigil was scheduled after the meeting in honor of the victims of recent mass shootings in El Paso, Texas, and Dayton, Ohio. Mr. Frazier acknowledged the police officer present at the meeting, stating the officer was the first line of defense in an event such as a shooting. Mr. Frazier stated individuals with mental health issues or wrongful speech and behavior should be addressed before they gain access to guns and resort to deadly violence, because it could happen anywhere including our own communities. Mr. Frazier thanked Mayor Fuller and city staff for quickly organizing the vigil after the shooting events that happened on August 3rd and 4th.

Council Members La'Shadion Shemwell, Scott Elliott, and Charlie Philips had no comments.

City Manager Paul Grimes announced the National Night Out block parties would take place on Tuesday, August 6, and encouraged residents to attend their neighborhood activities to increase neighborhood spirt and improve police-community partnerships for safety; Mr. Grimes stated residents could look forward to seeing the City Council Members and Police Chief Conley visiting communities throughout the city, and he provided information for groups to register their events. Mr. Grimes shared customer compliments about Water Distribution Utilities Supervisor Michael George, Water Distribution Maintenance Specialist Jeremy Murphy, Water Distribution Maintenance Crew Leader Fernando Barrio for their impressive work, problem solving, and customer service during the water line replacement project in the Briar Ridge community. Mr. Grimes also noted the leadership of Water Distribution Utilities Superintendent Craig Sherwood.

Mayor Fuller thanked city staff and Amy Rosenthal (Director of McKinney Performing Arts Center & McKinney Main Street) for their efforts in coordinating the candlelight vigil to be held at 8:20 p.m. at Mitchell Park, following the City Council meeting. The event will be non-political but Mayor Fuller expressed agreement with the comments made by Council Member Frazier, and a wish for the leaders in our country to put down "partisan nonsense" to achieve real solutions to deal with issues. Mayor Fuller also the concrete plants in the city.
