## CITY COUNCIL REGULAR MEETING

## **SEPTEMBER 17, 2019**

The City Council of the City of McKinney, Texas met in work session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Tuesday, September 17, 2019 at 3:00 p.m.

Mayor George Fuller called the meeting to order at 3:05 p.m. upon determining a quorum of the Council was present.

Mayor Fuller called for discussion of the agenda items for the City Council Regular Meeting to be held Tuesday, September 17, 2019 at 6:00 p.m. There was no discussion of those items.

Mayor Fuller called for the following work session items:

**19-0762** Update on the Enterprise Resource Planning (ERP) Request for Proposal

Chief Information Officer Sid Hudson presented information regarding the vetting process and upcoming demonstrations of software for evaluating ERP vendor candidates.

**19-0763** Update on Texas Intrastate Fire Mutual Aid System Program (TIFMAS)

Fire Chief Danny Kistner and Fire Captain Ben Jones explained the purpose of the TIFMAS program for Fire Departments to provide support and emergency assistance to other agencies during emergencies, described some of the resources and training McKinney employs for the program, and explained how expenses for services are reimbursed to the city. McKinney recently deployed personnel to assist wildfires in different areas across the state.

19-0764 Update on House Bill 2840 Regarding Citizens Comments at an Open Meeting

City Secretary Empress Drane and City Attorney Mark Houser explained an amendment to the Texas Open Meetings Act which grants the rights of the public to address meeting agenda items.

Mayor Fuller called for Council Liaison Updates.

Council Member Charlie Philips stated the Audit Committee met earlier in the day, and he recognized and commended the Finance Department, as the audit reports reflected highly on their work.

Council Member Scott Elliott recognized the performance of the McKinney Economic Development Corporation under the leadership of President Peter Tokar III and Chairman Kenneth Sipiora. Mr. Elliottt stated the board freely engages in robust conversation, including opposing views, while still productively working together.
