## **Background Information**

- The Low-Income Transit Subsidy Pilot Program occurred from April 2, 2018 to March 31,
   2019 and allowed income-qualified residents to participate in Collin County Transit
- On January, 16, 2019, the Board approved implementing Low-Income as a permanent qualifying criteria alongside Elderly and Disabled after the end of the pilot program
- FTA Section 5307 will reimburse low-income expenses if it meets the low-income definition
- FTA defines "low-income" as persons at or below 150% of the U.S. Poverty Guidelines published by the U.S. Department of Health and Human Services (5307 Circular 9030.1E)
- Currently, Collin County Transit's income ranges are approximately 160% of the U.S.
   Poverty Guidelines
  - This means all low-income expenses are not reimbursable by the federal grant. As a result, these expenses are billed only
    to the state grant


## **Item Summary**

- Staff is seeking Board approval on whether or not to change Collin County Transit's income qualification policy




## Low Income Expenses

- 54 qualified low-income participants; 26 riders
  - 44 McKinney
  - 6 Princeton
  - 4 Prosper
- 940 trips taken
- Average cost per trip: \$12.29
- Average miles per trip: 4.86
- Average monthly growth for new riders over the past six months: 22%
