Chairman Sipiora called the meeting to order at 8:01 am after determining a quorum present.

Chairman Sipiora called for Public Comments. There were none.

<u>City of McKinney</u> - Assistant City Manager Shelton announced the City Council meeting scheduled for this evening has been canceled. The next City Council meeting is scheduled for December 3, 2019. Assistant City Manager Shelton noted they will be discussing the McKinney Flats Project. The project is a request for multifamily rezoning located off Collin McKinney Parkway near Craig Ranch. Assistant City Manager Shelton noted the project is being proposed for the Housing and Finance Commission to provide Affordable Housing. Assistant City Manager Shelton noted City Council will be reviewing the Mobile Home Ordinance to give code enforcement and building inspections more authority as it pertains to the exterior of the homes to ensure they are being maintained. Assistant City Manager Shelton reported the City will be requesting funds from the McKinney Community Development Corporation to assist in completing the Star Center. The City has a RFQ out to select a design build partner. The Dallas Stars are anxious to continue the process and have been working with builders and contractors over the last 9-12 months to ensure the project will be in budget.

<u>Visit McKinney</u> – Executive Director Guerra announced the Drum Corps International will be here in July 2020 featuring eight world class Drum Corps. Executive Guerra also noted the NCAA D2 football game tickets are on sale and prices will go up December 9<sup>th</sup>. Executive Director Guerra invited the board to attend Karaoke for Cans at Tupps this Thursday 5:30 pm to 7:30 pm.
