The individual(s) collecting the signatures contained on the pages submitted with and made a part of this Zoning Change Written Protest Withdrawal form shall be required to complete the Zoning Change Written Protest Withdrawal Signature Witness Affidavit. (Please note that individual owners of eligible property may submit an individual Zoning Change Written Protest Withdrawal form, which form is available from the City, rather than sign this form.)

Note: A written withdrawal of protest must be received on or before the 4th working day prior to the <u>initial</u> zoning hearing date and on or before the 2nd working day prior to any <u>continued</u>, <u>re-noticed or tabled</u> hearing date.
