Mayor Fuller called the meeting to order at 3:05 p.m. upon determining a quorum of the City Council was present.

Mayor Fuller called for public comments.

Council Member Charlie Philips stated the Historic Preservation Advisory Board approved one property to be recognized as an historic property; and he thanked to Assistant Director Public Works Paul Sparkman and department staff for their work at the recent holiday parade; John & Judy Gay Library will be closed for construction January 6-13, 2020.

Council Member Scott Elliott stated the MEDC is closing one of its best calendar years ever, including the pipeline of projects in the works and a classy and competent team that is data-driven and knowledgeable.

Mayor Pro Tem Rainey Rogers, referencing MEDC, stated there's nothing but good news from economic standpoint in McKinney, encouraging news for the year; commended and thanked the Building & Standards Commission for completing the tedious work that needs to be reviewed and approved.

Council Member La'Shadion Shemwell stated the Library Advisory Board will meet on Thursday, December 19, 2019 at 5pm at John & Judy Gay Library.

Council Member Frederick Frazier was unable to attend the recent Parks & Recreation meeting due to court but expressed interest in the participation results of the new special event, Wonder by the Apex Centre, will is held several weekends in December; the McKinney Community Development Corporation will meet tomorrow. Mr. Frazier stated the Christmas parade was special, and he hasn't missed the event in his

eleven years of living here; commended Main Street Director Amy Rosenthal and those who contributed to the parade. Mr. Frazier invited Police Motorcycle Officer Hoya, who was injured while serving at a vehicle accident, and his family to participate in the parade.

Mayor George Fuller expressed agreement for the previous comments regarding MEDC and Christmas parade.
