Requirements Policy

This agenda item revisited a request by Board on August 14, 2019 for staff to evaluate the possibility of increasing the income eligibility range for applicants of the Low-Income Transit Subsidy Pilot Program. Transit Administrator Anthony Cao stated the current policy allows participation for individuals with income at or below one hundred fifty (150) percent above the U.S. Poverty Guidelines established by the U.S. Department of Health and Human Services. Mr. Cao requested the Board to consider modifying the policy to allow participation for individuals with income at or below one hundred sixty (160) percent above the Poverty Guidelines. The increase to allow more eligible participants would limit federal and state aid available to the program, and consequentially affect funding to other city programs. The board requested additional information regarding the potential number of new eligible participants and financial data. The MUTD Board unanimously approved the motion by Board Member Richard Franklin, seconded by Board Member Frederick Frazier, to table the item to another

19-0951 Collin County Transit Hardship Pilot Program

Transit Administrator Anthony Cao introduced a Pilot Program to offer free taxi

voucher services to individuals experiencing hardships such as homelessness,

unemployment, and severe poverty. MUTD would allocate up to two hundred seventy-

five thousand (275,000) dollars for the initial twelve-month period of the program and

provide seventy-five (75) percent of the service cost. The application and approval

process would be administered through a specified number of non-profit organizations

that would also subsidize the twenty-five (25) percent portion of the service fee not

covered by MUTD funding. The organization may pay that cost or require some

payment from participants.
