There were approximately one hundred twenty-five (125) members of the public present at the meeting.

Mayor Fuller called for the Invocation and recital of the Pledge of Allegiance.

The Invocation was given by Senior Pastor Deborah Bradford of New Jerusalem Baptist

Church. The Pledge of Allegiance was led by Youth Members of New Jerusalem Baptist Church.

Mayor Fuller called for the following information sharing items:

Civilian nurse Jennifer Inman was recognized for rendering life-saving CPR aid to Thomas Cook on January 26, 2020 at downtown McKinney. Ms. Inman received a civilian recognition award plaque from Mayor Fuller and stood for photographs alongside Mayor Fuller, Fire Chief Danny Kistner, Mr. Cook, Fire Services Medical Director Elizabeth Fagan, and approximately ten (10) other Firefighters and Emergency Medical Services (EMS) members.

**20-0170** Proclamation for The League of Women Voters 100th Anniversary

Mayor Fuller read a proclamation for the one hundredth (100<sup>th</sup>) Anniversary of The League of Women Voters, recognizing the organization's historic role in supporting public awareness for election processes, election candidates, and voting. Several members of the organization were present to receive the proclamation and stood with Mayor Fuller for photographs.

Mayor Fuller called again for Citizen Comments, at which time there were no requests by members of the public to speak.

Mayor Fuller called for Council and Manager Comments.

Council Member Charlie Philips acknowledged Black History Month and recognized Mr. Jesse Gowen (namesake of McGowen Elementary School) and Mrs. June McGowen, who were present in the audience. The McGowens were among the first African-American educators to help integrate McKinney schools. Council Member Philips also expressed appreciation and respect for the McKinney history of Leonard Evans (namesake of Evans Middle School), Reuben Johnson (namesake of Johnson Elementary School), St. James CME Church and Doty School. Council Member Philips recognized Cameron Frazier (daughter of Council Member Frederick Frazier). Cameron is a member of the Faubion Middle School girls 8<sup>th</sup> basketball team, which won the district championship.

Council Member Elliott Scott commended the work of the McKinney Economic Development Corporation (MEDC) staff and board members.

Mayor Pro Tempore Rainey Rogers expressed appreciation for the McGowen family, noting that Mr. McGowen was an administrator during his tenure in school, and Mrs. McGowen taught many of the Mayor Pro Tem's family members.

Council Member La'Shadion Shemwell recognized and thanked a McKinney High School student who was present at the meeting for a journalism assignment. Council Member Shemwell expressed concern about the airport payment issues presented during the citizen comments, as well as comments from Warren Owens and Shirley Mack and the role of the city in assisting residents with community issues. Council Member Shemwell acknowledged the McGowen family, mentioning the voting rights act, school integration in McKinney schools. Council Member Shemwell stated the attendance of more Black residents at Council meetings during his tenure is progress.

Council Member Frederick Frazier thanked the members of the public who submitted comments and bringing issues to the attention of the Council in a good way.

Philips for acknowledging his daughter's basketball accomplishment.

City Manager Paul Grimes announced that McKinney Public Libraries and

McKinney Fire Station along with AARP will offer free tax preparation services at

various locations across the city. Informational information about service locations,

times and required documents to bring is available on the city web site.

Mayor Fuller stated the Martin Luther King, Jr. event at the McKinney Performing

Arts Center on Sunday, February 16 including discussion and a photo gallery. Mayor

Fuller acknowledged the Black pioneering figures of McKinney, stating that he looked

forward to the next event. Mayor Fuller expressed concern for the airport payment issue

presented during the citizen comments and committed to resolve the problem. Mayor

Fuller mentioned early voting was underway for various elections, as well shared

information for how the 2020 Census will contribute to funding for public services of the

future, encouraging all people living in the city to participate in being counted.

The Council did not meet in Executive Session.

Council unanimously approved the motion by Council member La'Shadion

Shemwell, seconded by Mayor Pro Tem, to adjourn. Mayor Fuller adjourned the

meeting at 7:59 p.m.
