My name is Brant Beland and I am writing to you on behalf of several local Democratic organizations I am involved in, as well as members of the community who have expressed interest in another peaceful protest in the downtown area.

As you are aware, the Black Lives Matter movement continues to push forward, even several weeks after George Floyd's death. As you may also be aware, it is also PRIDE month for the LGBTQIA+ community, who also just won a major Supreme Court case protecting them from discrimination. This has led us to propose the idea of joining together in solidarity and holding a peaceful protest for both of these groups.

We are looking at a date of June 27th at 5PM.
