Policies

- 8 can't wait?
 - **1.** Banning chokeholds and strangulation MPD bans these techniques. MPD policy also bans Strikes to the head or neck with intermediate weapons. Use of such techniques could only be used when deadly force is authorized.
 - **2.** Require de-escalation De-escalation is required whenever possible. Extensive training is given on de-escalation techniques
 - **3.** Require warning before shooting While not required, Officers are trained to engage subjects verbally and we emphasize dialogue, verbal commands, and instructions.
 - **4. Exhaust all other means before shooting** Only objectively reasonable force is allowed. Using the least amount of force is part of training. Officers are trained on a force spectrum that provides a myriad of options that may be employed depending on the specific situation at hand. The force spectrum includes: Physical Presence, Verbal Persuasion, Hand Control, ECW, OC spray, Intermediate weapons, Deadly Force

Policies

- 8 can't wait?
 - **5. Duty to Intervene** Officers are required by policy to intervene when unreasonable force or other unreasonable behavior is observed in a fellow officer. This is without regard to rank level and is without retribution. A supervisor is required to be notified.
 - **6. Ban Shooting at Moving Vehicles** Shooting at moving vehicles is against MPD policy in most every instance. Exception is made for vehicles being used as a weapon, e.g. a vehicle being driving into a crowd of people.
 - **7.** Require the use of a force continuum Our policy contains a force spectrum which provides options based on the totality of the circumstances officers face in a given moment.
 - 8. Require comprehensive reporting All uses of force require documentation and supervisory review through the chain of command. These reviews determine if the use of force conforms to MPD policy and training.
