#### **COVID-19 Emergency Relief**

A total of 271 applications were received for the Covid-19 Small Business/Nonprofit Grant program approved by Council and MCDC and funded through MCDC. The application period was May 1 through May 10.

231 applications have been approved for a total of \$340,012.87

40 were declined (of that number 10 were duplicates or test apps). Reasons for decline were business location not within the McKinney city limits (8); residential address (8); no physical location provided (1); insufficient hardship or expense documentation provided (13).

## Eligibility criteria:

- Business/nonprofit entity confirmed
- Commercial location within McKinney city limits
- EIN Provided
- 50 or fewer FTEs
- W-9 on file
- Documentation of minimum of 2 hardships as a result of COVID-19
- Business expenses (lease, utility, communications, trash, wireless, internet, etc. for March and April) to equal/exceed the grant amount being requested

Funding began the week of May 18. Maximum funding amount was \$1,500 for eligible business expenses, incurred in March and April, for rent, utilities, communications, website, wireless, internet services.

Round 2 of the McKinney Strong Small Business Grants was approved by MCDC on 5/28 and Council on 6/2. The second round will provide an opportunity for Small Businesses within City limits that did not complete an application during Round 1 to apply and was expanded to include an opportunity for Home-based Businesses in McKinney to apply for a grant.

Maximum grant awards continue to be \$1,500 for a small business and \$1,000 for a home-based business.

The application period opened June 8 and will close on June 18.

Also, at the May 28<sup>th</sup> board meeting, a public hearing was conducted on project grant, #20-09, submitted by TUPPS Brewery. The grant application requests \$11,333,262 for rehabilitation and revitalization of a property at Greenville and Dungan streets to create a cultural and entertainment destination to serve as a catalyst for economic development east of Highway 5.

Board action on this request will be scheduled for the June 25<sup>th</sup> meeting.

Applications are being accepted through June 30<sup>th</sup> for the third and final cycle of project grants for the current fiscal year. Applications received will be presented to the board at the July 23<sup>rd</sup> meeting with board action scheduled for August 27<sup>th</sup>.

# **Retail Development Infrastructure Grants**

The application period for the second round of Retail Infrastructure Grants will open July 1<sup>st</sup>. This is a matching grant program available to support "legacy" retail, with maximum grant awards set at \$25,000. Eligible expenses are for horizontal infrastructure exterior to a building – site, sewer, utilities, water, drainage.
