Dear Councilmen,

My name is Reilly Clark. Last month, I spoke to you about our city's statue of James Webb Throckmorton and the failure of values that it represents. I am imploring you a second time to make a statement about who we are as a city – who we want to be – and remove this disgraceful and misleading monument. Yes, the statue of Throckmorton is a problem that needs to be solved. But more than that, it is an opportunity to set the record straight.

When I first spoke to this council, I laid out the facts. Throckmorton fought in open rebellion against this country for the explicit purpose of perpetuating slavery. This is not an opinion. This is a matter of historical fact. Alexander Stephens, the Vice-President of the Confederacy and the man to whom Throckmorton pledged his allegiance, called slavery -- by name -- the cornerstone of the Confederacy.

This is cause for which James Webb Throckmorton pledged his life. As an officer in the Confederate Army, he would have died to keep enslaved people enslaved. This man now watches over our streets. Councilmen, removing his statue would not be "erasing history." Rather, removal recognizes of history as it really was. Throckmorton decided what side of history he wanted to be on long ago. Now, we face the same choice.






