## **CITY COUNCIL REGULAR MEETING**

# **AUGUST 18, 2020**

The City Council of the City of McKinney, Texas met in regular session in the McKinney City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Tuesday, August 18, 2020 at 6:00 p.m.

Mayor Fuller called for Council and Manager Comments.

Council Member Charlie Philips acknowledged several McKinney native residents John Hardin, Bill Cox, Nina Ringley, and Rainey Rogers, who grew up in McKinney and currently continue to live in and serve the city.

Mayor Pro Tem Rainey Rogers stated all City Council members represent the entire city; thanked the city Public Works staff for working late hours to clean up recent storm damage; and acknowledged Pete Boleneus of Timberblinds for his investment and efforts to preserve jobs in McKinney.

Council Member Frederick Frazier acknowledged the 100<sup>th</sup> Anniversary of the 19<sup>th</sup> Amendment to the Constitution and expressed gratitude for his women-led campaign team, and the efforts of women, including his wife, who fight for their rights every day. Council Member Frazier thanked Census workers and emphasized the importance of everyone being counted; thanked the public for attending or viewing the Council meeting and commended the progress of the city in continuing to work.

Council Member Rick Franklin expressed appreciation for the Housing Hub program that was presented at the earlier Work Session by the Development Services department.

Council Member La'Shadion Shemwell expressed optimism about the direction of the city and the Council's commitment to working together to do what is best for the city and encouraged participation in the Census.

Mayor George Fuller committed to working for the good of the community and read a statement about recent protest activity near city hall, speaking against hateful comments and behaviors that foster fear, intimidation, and racial division; acknowledged Asia Smith for coordinating a recent community outreach event which he and Council Member Shemwell attended.

City Manager Paul Grimes made city announcements:

- Assistant Director of Public Works Paul Sparkman is coordinating more than one hundred cleanup assignments in response to recent storms. The Parks & Recreation department is also supporting the cleanup effort.
