Mayor Fuller called for Council and Manager Comments.

Council Member Philips stated that he received a call from an attorney that works Downtown McKinney regarding how friendly and helpful the construction workers were being to citizens Downtown. Council Member Philips congratulated the staff that made the selection to hire the construction company. Council Member Philips also mentioned that the City of McKinney's Fire Department has been on the News on their response to the wild fires in California and Hurricane Laura; Philips stated that he is proud that our Firefighters are not only serving McKinney, but the entire Nation. Council Member Philips spoke about what was happening in the Throckmorton Ad Hoc Advisory Board and that he is proud of the open, honest, and frank conversations that they are having in their meetings. Council Member Philips also informed the Council that Highschool Football is starting back.

Council Member Elliott thanked Derrick and Ceretha Robinson of Alliance for Elite Youth Leadership (AEYL). Community Lifeline Center and AEYL held a joint event to give food to the Community. The event provided food for nine hundred (900) families and handed out sixty thousand (60,000) pounds of food. Council Member Elliott also informed the Council that they will hold another event on September 26th.

Council Member Shemwell stated that he appreciates the work that that has been put in to lead in the right direction. Council Member Shemwell stated that a lawsuit has been filed due to the rectifying of the City's Charter Amendments regarding the Recall election. Council Member Shemwell hopes that the City will do the right thing by the voters and constituents of District 1.

Council Member Frazier thanked Wendy Gallagher, the Staff, McKinney Chamber, and the McKinney Alumni that hosted the City's September 11th Memorial for all the thought and effort that they put into it. Council Member Frazier urged citizens to complete the 2020 Census if they have not already done so and to remember election day of November 3rd. Council Member Frazier thanked the McKinney Firefighters that have assisted with the wildfires in California. Council Member Frazier tasked citizens to shop and eat in McKinney.

I'm confused about what kinds of units are being counted as affordable in this report. I'm also seeing a 2018 federal report being referenced that may not be giving us the up-to-date numbers we need for existing or units in the works. What is included in the "total affordable units" number was not defined in the presentation for the work session. The total affordable units is different in the presentation (it says 2,648) and in the report (publicly assisted rental units 2,483) itself. I emailed the consultant, but I have not gotten a response yet.

I ask the details of the affordable number because it appears that the total of publicly assisted units (vouchers + LIHTC) is all

that is being considered "affordable." But, we also have many other private affordable housing options that might or might not be included in the "affordable" units number used in this report. Here are a few examples: the container homes, trailer parks, smaller duplexes, or older, small apartment complexes that might be more common downtown and in east McKinney. Last time I asked, those were not being included in the total number of affordable units. They should also be counted. In Section II on page 28 of the report, it states that 90% of apartment renters in McKinney want to be homeowners. If anyone remembers, we were assured during the creation of the comprehensive plan that the majority of renters wanted to keep renting, which was why the city put - I ran out of characters.
