Conduct a Public Hearing to Consider/Discuss/Act on the Request by Kevin and Melissa Mansell for Approval of a Level 1 Historic Neighborhood Improvement Zone Tax Exemption for the House Located at 616 N. Church Street. Mr. Mark Doty, Assistant Director of Planning for the City of McKinney, explained the proposed Level 1 Historic Neighborhood Improvement Zone Tax Exemption request. He stated that the house is a high priority building and had been maintained. Mr. Doty stated that the estimated ad valorem taxes for this property in 2020 is \$1,937 and the estimated abated amount for the seven-year period being \$13,561. He stated that Staff was recommending approval of the Level 1 Historic Neighborhood Improvement Zone Tax Exemption for the house located at 616 N. Church Street. Mr. Doty offered to answer questions.
