The City Council of the City of McKinney, Texas met in work session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas on Monday, October 4, 2021 at 4 p.m.

Mayor Fuller called for discussion of the agenda items to be presented at the City Council Regular Meeting of Monday, October 4, 2021, at 6:00 p.m.
