CITY COUNCIL REGULAR MEETING

APRIL 2, 2024

The City Council of the City of McKinney, Texas met in regular session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Tuesday, April 2, 2024, at 6:00 p.m.

The meeting was broadcast live on cable television Spectrum Channel 16 and AT&T U-Verse Channel 99; and online at https://mckinneytx.new.swagit.com/views/130. A video recording of the meeting is available to members of the public through the City of McKinney meeting archive.

Mayor George Fuller called the regular meeting to order at 6:03 p.m. upon determining a quorum consisting of himself and the following members were present: Mayor Pro Tem Charlie Philips and Councilmembers Justin Beller, Geré Feltus and Michael Jones.
