The McKinney Convention and Visitors Bureau Board met in regular session at the Encore Board Room, 111 N. Tennessee Street, McKinney, Texas on October 25, 2016 at 7:30 am.

After establishing a quorum was present, Executive Director Guerra called the McKinney Convention and Visitors Bureau board meeting to order at 7:37 a.m.

- 16-1100 Presentation from the Sheraton Hotel & Conference Center Sheraton General Manager Ryan Miyamoto and Director of Sales Dawn Patterson advised Board members that the Sheraton is working on closing out their second year. Director of Sales Dawn Patterson presented to the Board and advised that the Starwood properties had been bought out by Marriott. Ms. Patterson stated the main focus from the merger of the two companies was going to be on the loyalty programs. She also advised Board members that although many hotels in the Dallas area had been flat in the year-over-year occupancy, the Sheraton McKinney has continued to grow and their close-out for the year was at 72 percent. Ms. Patterson also advised Board members that the Sheraton Sales team's main focus for the upcoming year was going to be on group business. In

addition, Ms. Patterson informed Board members that the Sheraton's group room nights was up six-thousand year-over-year.

16-1101 Board & Liaison Reports

Board Chair – Former Board Chair Hal Harbor thanked Board members for the opportunity to serve as their Chair and turned the responsibilities over to incoming Board Chair Wayne Hill. Mr. Hill thanked Board member Harbor for his dedication to the MCVB Board and staff as well as for his leadership during his tenure as Board Chair.

City of McKinney – City Manager Paul Grimes spoke regarding the Parks & Recreation Department and advised that the Dallas Stars would be adding another sheet of ice to the McKinney Star Center. Mr. Grimes advised Board members that the McKinney Star Center Ice Rink is the most successful community rink for the Stars. Mr. Grimes also advised Board members that the Ballfields at Craig Ranch will slowly be phased out as it is privately owned and being sold. Additionally, Mr. Grimes informed Board members that both the City and the MCVB have been working together to bid on the National Association of Intercollegiate Athletics (NAIA) tournament for 2018. Furthermore, Mr. Grimes informed Board members that the Apex Center is online to open in February/March 2017. The Movie House Eatery has opened in Craig Ranch, The Holiday Inn at Craig Ranch is scheduled to open November 23, 2016 and City Council will be approving the plan to move forward on the 9-Acre Site just south of City Hall on Highway 5.

Finance Committee – Committee Chair Hill reported that the HOTTAX continues to increase year-over-year as well as occupancy. Mr. Hill stated that our sister cities have been flat. He thanked the MCVB staff for their efforts in selling the city.

McKinney Chamber of Commerce - MCVB Executive Director Guerra reported on behalf of the Chamber and advised Board members that the State of the City event would be held at Christ Fellowship Church on November 3, 2016.

McKinney Performing Arts Center/Main Street – MPAC/Main Street Director Amy Rosenthal informed Board members of the upcoming events taking place in downtown McKinney: Scare on the Square, Aaron Neville, and Home for the Holidays. Ms. Rosenthal also advised Board members that they are currently conducting a fundraiser to reach the goal of \$5000 for the downtown Christmas Tree.

- 16-1102 Executive Director's Report Executive Director Guerra announced to Board members that staff member Vanesa Rhodes was awarded her Texas Destination Marketer (TDM) Certificate at the annual Texas Association Convention and Visitors Bureau (TACVB) conference that was held in El Paso in August. In addition, Ms. Guerra announced Ms. Rhodes accepted the Sales Manager position for the MCVB. Ms. Guerra asked Board members to refer to the Executive Director's report and asked if anyone had any questions. She also reminded Board members that this year's TTIA Unity Dinner would be a Legislative year and asked Board members to advise her if they would like to attend the dinner/event that would take place in Austin February 15-17, 2017.
