REGULAR MEETING

FEBRUARY 28, 2017

The McKinney Convention and Visitors Bureau Board met in regular session at the MCVB Conference Room, 200 West Virginia, McKinney, Texas on February 28, 2017 at 7:30 a.m.

Board members unanimously approved the motion by board member Jim Bressler, seconded by board member Sally Huggins, to approve the following consent agenda items:

- 17-241 Presentation from Main Street Director Amy Rosenthal on Transportation for Downtown. Director Rosenthal proposed to have an electric shuttle that seats six passengers. The projection of hours to run the shuttle is 20-30 weekly hours at a cost of 30 cents a day to operate. MCDC is funding the purchase of a Polaris to run as a no cost (free for all riders) service as a short term solution for a long term downtown parking issue.
- 17-242 Executive Directors Report - Executive Director Guerra updated board

members with a few highlights including: Beth Shumate got one of her pictures picked up by USA Today which equaled approximately \$40,000 in free advertising. Beth also earned her TDM this year at the annual conference of the Texas Association and Convention & Visitors Bureau. Vanesa Rhodes received and forwarded an RFP from the Texas Rural Letter Carriers Association to the Sheraton Hotel and Conference Center. Ms. Guerra attended the "For Women For Life," trade show and the Annual Chamber meeting.

17-243 Board & Liaison Reports

City of McKinney — City Manager Paul Grimes advised board members about the First McKinney Urban Transit District Program Meeting being held that afternoon at the John and Judy Gay Library. In addition he informed members that Council had a joint meeting with McKinney ISD on February 27, 2017. Mr. Grimes gave an update for the Gateway Project including staff approval and discussion with the developer regarding a start date for the project. Director of Strategic Services Chandler Merritt gave a legislative update regarding uniform school start date and Senate Bill 6. Mayor Loughmiller shared enthusiasm of the Apex Centre opening that morning (February 28, 2017). Additionally, he updated board members on the Resort Hotel at Craig Ranch, and stated Council has given permission to city staff to negotiate a deal. Mr. Grimes added, the development around the proposed Costco project site at 380 and Hardin is scheduled to begin in late spring.

Main Street/MPAC – Executive Director Amy Rosenthal reviewed the upcoming events taking place downtown highlighting Arts in Bloom which will be held April 7-9.

MCDC – Board chair Kurt Kuehn stated the MCDC Board approved partial funding for a new sheet of ice at the Dr. Pepper StarCenter. In addition he informed board members about the Apex approval and how it came into completion. He also advised of MCDC's partnering with Main

Street to purchase the electric shuttle for the downtown area.

<u>Finance Committee</u> – Board member Jim Bressler provided an update on

the January HOTTAX and stated the average daily rate continues to

climb. Additionally he stated that McKinney hotels are showing great

growth over those in Plano, Allen and Frisco. Mr. Bressler informed

Board members the new Holiday Inn Express in Craig Ranch is

scheduled to open in March. Additionally two more extended stay hotels

will open this year. He stated with the addition of these hotels we will see

an increase in HOTTAX. Bressler stated that the MIM store revenue has

declined from its inception and the finance committee is discussing the

redirection of the consignment contract and how to move forward.

HR Committee - Committee Chair Perkins provided an update on the

strategic plan and goals of the MCVB. He advised board members that

moving forward, discussions for updating the strategic plan and goals

will begin in August with approval taking place in September. The

implementation of the updated plan and goals will now take place in

October.
