17-005HTM Conduct a Public Hearing to Consider/Discuss/Act on the Request by Paul and Deanna Rearden, for Approval of a Historic Marker for the House Located at 613 West Hunt Street

Mr. Guy Giersch, Historic Preservation Officer for the City of McKinney, explained the Historic Marker application and stated that Staff was recommending approval of a Historic Marker for 613 W. Hunt Street. He offered to answer questions.

Board Member Ball asked if this was the only hybrid style house like this in McKinney. Mr. Giersch said no and that there were several in McKinney,

Mr. Paul Rearden, 613 W. Hunt Street, McKinney, TX, explained the request and gave a brief history of the work done to the house and property.

Board Member Zupanic asked for the square footage of the house. Mr. Rearden stated that it was 2,710 square feet.

Mr. Guy Giersch, Historic Preservation Officer for the City of McKinney, explained the proposed Level 1 Historic Neighborhood Improvement Zone Tax Exemption request and stated that Staff was recommending approval of the Level 1 Tax Exemption for 613 W. Hunt Street.
