## **COMMUNITY GRANTS ADVISORY COMMISSION**

## May 31, 2018

The Community Grants Advisory Commission of the City of McKinney, Texas met in regular session in the 2<sup>nd</sup> Floor Conference Room, City Hall, 222 N. Tennessee Street, McKinney, Texas on May 31, 2018 at 6:30 p.m.

Commissioners Present: Chairman Randy Hubbard, Vice Chairman Essie Hennie, Commissioners Adriana Pedraza, Kelly Buettner, Samuel Franklin, and Jennifer Mott. Absent: Commissioner Stella Stevens

Staff Present: Shirletta Best, Community Services Administrator; Camille Smith, Community Services Coordinator; and Judy Hawkins, Administrative Assistant

Chairman Hubbard called the meeting to order at 6:57 p.m. after determining the presence of a quorum.

Chairman Hubbard called for the Consent Items. Commissioners unanimously approved the motion by Commissioner Buettner, seconded by Commissioner Mott, to approve the following minutes:

- 18-456 Chairman Hubbard called for Consideration/Discussion/Action on the FY 2018-2019 Funding Allocations for Community Development Block Grant Recommendations to City Council. Administrator Best stated that funding for the CDBG (Community Development Block Grant) and Community Support Grants would be effective as of October 1, 2018. The City of McKinney receives federal funding from the Department of Housing & Urban Development (HUD). It is estimated that the City will receive \$758,765 in CDBG funding, 15% of which is used for Public Services, 20% for grant administration, and 65% for housing services,

housing rehabilitation, and community and economic development. Community Support Grants are funded by the City of McKinney; the funding amount is recommended by City Council within the annual budget process. Grant applicants presented their application requests to the Community Grants Advisory Commission on May 9 and May 10. Applicants for grants were considered based on capacity, regulatory requirements, past performance, if applicable. The Commissioners unanimously approved the motion by Commissioner Pedraza, seconded by Commissioner Franklin, to approve the following funding recommendations:

Community Support Grant funding dollars could be awarded, if the

budget was increased. Commissioners unanimously approved a motion

by Commissioner Pedraza, seconded by Commissioner Mott, to

distribute any additional funds proportionally to the Commission's

Community Support Grant funding recommendations.
