Council Member Elliott recognized the Apex Centre and Manager Teresa Thomason for recently hiring 30-05 summer Aquatic Staff. More than 100 vacancies remain, and additional hiring events will take place to fill them.

Mayor Pro Tem Rath stated the McKinney Community Development Corporation (MCDC) met the previous Thursday and awarded nearly \$74,000 of the available \$75,000 of Community and Promotional grants. The recipients included the Collin County History Museum "McKinney Then and Now" exhibit; McKinney Main Street Cultural District events; ManeGait (Therapeutic Horsemanship); Kiwanis Club; and others. The Main Street board also considered presentations for regular grants.
