CITY COUNCIL WORK SESSION

NOVEMBER 5, 2019

The City Council of the City of McKinney, Texas met in work session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Tuesday, November 5, 2019, at 3:00 p.m.

Mayor Fuller called the meeting to order at 3:00 p.m. upon determining a quorum of the City Council was present.

Mayor Fuller introduced members of the Fire Department who were recently hired to the city or promoted to new positions:

Mayor Fuller called for Public Comments regarding items on the work session agenda.

Mayor Fuller called for discussion of agenda items for the City Council Regular Meeting to be held Tuesday, November 5, 2019 at 6:00 p.m. There was no discussion of those items.

Mayor Fuller called for discussion of the following work session items, with no action to be taken by the Council:

Mayor Fuller called for Updates on Boards & Commissions by the Council Liaisons to those boards.

Council Member Charlie Philips complimented the work of Visit McKinney staff and board members, stating they are an appreciated asset to the city. Utilizing a budget of six hundred seventy thousand (670,000) dollars, Visit McKinney has contributed to ten million two hundred thousand dollars in local tax revenue and twenty-four million dollars in state tax revenue, as well as securing advertising resources valued at nine hundred forty-two dollars from an allocation of one hundred seventy-four dollars. The Visit McKinney staff and board members present were recognized and stood for applause from the audience.

Council Member Scott Elliott congratulated the newest appointed regular board members to the McKinney Community Development Corporation (MCDC), John Mott and David Kelly, and alternate member Deborah Bradford. Mr. Elliott noted the value of alternate members, as Mrs. Bradford served as a voting member during the most recent meeting. Mr. Elliott congratulated and expressed appreciation for the the newly elected

board officers: Chair Jackie Brewer, Vice Chair Richard Glew, Treasurer Angela Richardson-Woods, and Secretary Mary Barnes-Tilley.

Council Member La'Shadion Shemwell, reporting on the McKinney Housing Authority (MHA), stated the newly redeveloped Merritt Homes were currently open to residents and a grand opening event would be held in January 2020. Mr. Shemwell stated the Merritt Homes and Newsome Homes, after lots of hard work, now provide beautiful affordable housing that people can take pride and dignity in. Mr. Shemwell also commended Newsome Home residents for actively participating in the most recent MHA meeting. Mr. Shemwell confirmed additional comments from Mr. Elliott that the redeveloped Merritt Homes accommodated more housing units than the old apartment units it replaced.

Council Member Frederick Frazier complimented and thanked the newly appointed members and newly elected officers of the MCDC, noting the board has a lot of work and important decisions to make in consideration of the city's growth. Mr. Frazier also wish "Happy Birthday" to Council Members Charlie Philips (November 2) and Richard Franklin (November 4).

Mayor George Fuller commented on the extensive work of the MEDC, expressing thanks to the staff and boards members for their efforts, including work in the nights and weekends.

Mayor Pro Tem Rainey Rogers and Council Member Richard Franklin had no updates to report.
