Alonzo Tutson, P.O. Box 1201, Anna TX 75409, thanked the Council for all the work that they have done and reminded the Council Members who serve at Large that they represent the entire City.

Sheilla Tutson, P.O. Box 1201, Anna TX 75409, spoke regarding Council Member Shemwell's past.

Mayor Pro Tem Rogers called for Council and Manager Comments.

Council Member Philips urged citizens to check out Hugs Café, in downtown McKinney, if they have not already visited and stated that Hugs Café just had their five (5) year anniversary. Council Member Philips acknowledged Kim Black for gaining a Historical Landmark designation for the Myrick House. Council Member Philips thanked City Secretary Empress Drane for speaking at the McKinney Kiwanis Club. Council Member Philips thanked Fire Chief Danny Kistner and Emergency Management Coordinator Karen Adkins for sending a firetruck to drive past Cornerstone Ranch to cheer up the residents. Lastly, Council Member Philips gave the following updates on sports in McKinney:

- JJ Henry from McKinney North is listed in the Top 10 Receivers in North Texas.
- Matteo Bianchi, a Linebacker from McKinney Boyd, got fifteen (15) tackles, a blocked kick, two (2) forced fumbles, a fumble recovery, a pass breakup, and six (6) tackles for loss in the game against Trophy Club.

Council Member Shemwell spoke regarding fearmongering and his campaign from 2017. Council Member Shemwell stated that he has served hard for the last three (3) and a half year and his works speak for themselves. The Council Member continued stating that he has pushed the Fire and Police Departments to do more and be better.

Council Member Franklin spoke regarding the State of the City Event on November 5, 2020.

Council Member Frazier spoke regarding domestic violence and police response.

Council Member Frazier thanked those who sent condolences to him about his Mother's passing.

Mayor Pro Tem Rogers spoke regarding Park land that is owned by the City of McKinney that is in floodplain and Proposition B that is on the November 3, 2020 ballot.

City Manager Paul Grimes updated the Council on the following items:

- The Housing Hub is now live online for information on the residential plan that the City has.
- As of October 1, 2020, the estimated population of the City of McKinney was 198,962.
- The 2020 Census ended on October 15, 2020. City Manager Grimes thanked all enumerators that participated this year to get everyone counted.
